

THE STATUTE OF THE CHORALIS WOOD ART COMPETITION

This statute governs the terms and conditions of the competition on social network Facebook and is the only binding document that governs this competition.

1. Purpose of the competition

The purpose of the competition is to promote the [Choralis Wood Art](#) brand through the company's Facebook profile.

2. Organizer of the competition

3. Competition date and draw

The date of the competition is from 28.10. 2022 until 7.11. 2022.

The drawing of winners will take place on November 8, 2022.

4. Winning the competition

There will be only one winner in this competition, who will win a [14-piece set of Christmas decorations from Mountain Maple](#) valued at €65.93.

5. Facebook and Meta has no obligations towards this competition

The competition is in no way sponsored, endorsed, or administered by this company and has no connection with the competition.

6. Conditions of participation in the competition

- a) An Individual older than 18 years of age and fully capable of legal acts and who agrees to the conditions of this competition may participate in the competition.
- b) The competition runs from 28.10.2022 - 7.11.2022. To enter the competition, participants must answer a question on the [Choralis Wood Art Facebook page](#): **What material is this Christmas set made of?**
- c) Only the contestant who answers the question correctly will be included in the competition.
- d) By participating in the competition, the participant agrees to the terms of this competition.

- e) By registering for the contest and sending the contest entry, the participant declares that he is the sole author of the entered entry and that the rights of third parties will not be violated using the contest entry. The participant is obliged to prove this fact at any time at the organizer's request. By submitting an entry, the contest participant grants the organizer and organizer of the contest an unconditional free license for the use of the contest entry and agrees that the organizer and organizer may publish and use the contest entry or part of it without time or territory restriction.
- f) If the winner does not comply with the rules of the competition, or tries to manipulate the competition, he/she will be eliminated from the competition, any right to win will be forfeited and a substitute winner will be determined according to the rules of the competition.
- g) Contributions containing profanity will be excluded from the competition.

7. Draw

- a) One randomly drawn person who has met the conditions of the competition wins.
- b) The winner will be determined by random drawing.
- c) After the end of the competition, on November 7, 2022, the organizer of the competition will automatically draw a random selection of one winner who will receive the prize.
- d) In case of impossibility of contacting the drawn winner, non-acceptance of the prize or in case of impossibility of providing the prize, a substitute winner will be drawn.
- e) A randomly drawn comment under the post that is correct wins.
- f) Unless otherwise specified, the competition ends at 23:59 CET on the specified day.
- g) The winner will be published on the [Choralis Wood Art](#) Facebook page on November 8, 2022, and also contacted by private message on Facebook.
- h) If the winner does not respond within 3 calendar days from the date of notification of the win, his right to win will be forfeited without the right to any compensation and a substitute winner will be appointed.
- i) [Choralis Wood Art](#) will ship the prize within 7 working days after receiving the address, unless otherwise agreed.
- j) The winner is not obliged to accept the prize.
- k) The organizer reserves the right to amend, modify or terminate the competition at any time without prior notice and without giving reasons.
- l) Winnings in the competition cannot be legally claimed or alternatively paid in money.
- m) m) The organizer is not responsible for the correctness of the contact data provided by the winner for the purpose of delivering the prize.
- n) n) The organizer of the competition is not responsible for non-delivery of the prize in the event of a change of address of the winner, of which he was not notified.

8. Distribution of winning price

- a) The prize will be sent to the drawn winner by Slovak Post to the address specified by the winner in the communication after the announcement of the win.
- b) The winner is obliged to prove his identity to the organizer upon request, for the purpose of exercising his rights or fulfilling his obligations according to these contest statutes.

9. Privacy

- a) By participating in the given competition, each participant agrees that his name on Facebook may be used to determine the winner of the competition in accordance with the legal regulations for the protection of personal data of [Choralis Wood Art](#).
- b) By participating, the Participant declares that all the information he has provided is true.
- c) Furthermore, the participant agrees to be contacted for the purpose of the award on Facebook.
- d) In this case, his address and telephone contact can be stored and used to deliver the prize.
- e) Giving consent to the processing of personal data is voluntary and the participant can request their free deletion at any time in writing at the address of the organizer.
